When a sale has been agreed the "Property Logbook is shared with the buyers solicitor creating economies of operation that enable the KEA Preferred Solicitor to offer a customer discount, this is helped by KEA agreeing NOT to receive a referral fee from the conveyancer.

# The KEA Preferred Solicitor Service Promise, helps to speed the process

- 1. We will make a welcome call to you within 4 hours of instruction
- 2. Your Starter Pack will be sent to you within 24 hours or made available for you online through the Property Logbook Data Room

- 3. We will return your calls the same business day
- 4. Your emails will be responded to within 4 hours
- 5. All letters will be replied to within two working days of receipt

### To Speed up the Sale:

SOLICITOR

- 1. We will be using the Property Logbook Data Room for safe and speedy communications with all parties
- 2. We will agree to take instructions on a No Sale No Fee basis, this enables you to instruct us when you instruct KEA. We can then carry out preliminary work to speed your sale. Your responsibility for costs does not start until we receive the KEA Memorandum of Sale

## On all Sale transactions, we will:

- 1. Apply for your title deeds and/or social copies within 24 hours of receiving your instruction.
- 2. Within 24 hours of receiving the KEA Memorandum of Sale or it being entered into your Property Logbook, we will issue the draft contract, if possible via the shared Data Room

### On all Purchases we will:

- 1. Request the draft contract within 24 hours of receiving your instruction.
- 2. Chase if not received within 5 working days
- 3. Request the Search Pack, as soon as your search payment has been cleared

### **Fixed Fees:**

 A fixed fee will be quoted, which means that you only pay what you are quoted, your fees will not change unless your instructions do

## Property Logbook Data Room:

 Good communication is at the heart of everything we do. You will be invited to log into your "Property Logbook" area of the secure data room to view documents, communications and third party information, all designed to keep your transaction moving forward
